



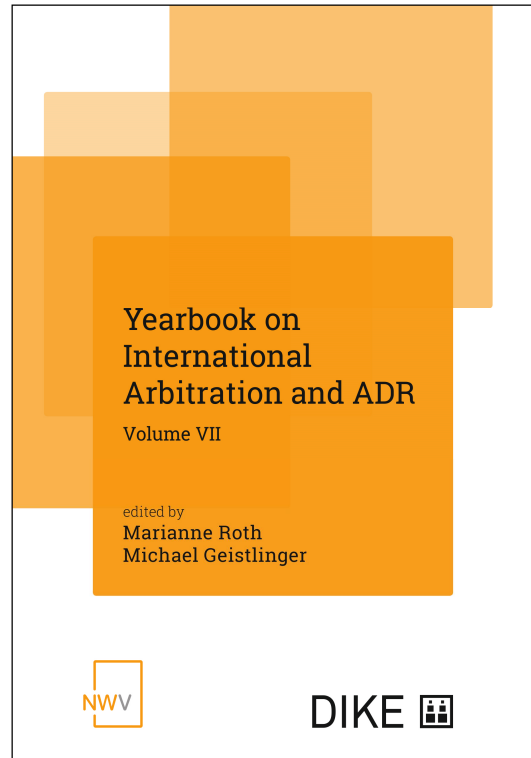

This yearbook series takes up recent trends in international arbitration, be it in the context of commercial disputes, investor-state conflicts, or sport controversies, and leads them in scholarly debate. Each volume imparts the knowledge of scholars and practitioners from all over the world and thereby delivers valuable insights into the intricacies of international arbitral proceedings.

**Volume I** – in honour of Jernej SEKOLEC – contains a collection of contributions by 25 renowned scholars and practitioners from around the world who offer unique insights into their work and experience in international arbitration, ADR and the applicable law, be it in the form of academic writings, annotations to cases, or other valuable connotations.

**Volume II** – in honour of Ingeborg SCHWENZER – highlights *inter alia* emergency rules, costs, and expert evidence in international arbitration, deals with dissenting opinions in commercial arbitration, reflects the ICC's arbitration clause for trust disputes, focusses on substantive and procedural issues of investment disputes and analyses the problem of creeping expropriation in this context. Moreover, specific emphasis is laid on mediation in Belgium, Germany, and Austria.

**Volume III** – in honour of Mauro RUBINO-SAMMARTANO – contains *inter alia* an analysis of the relationship between the increase in trade and the creation of dispute resolution institutions in MERCOSUL/R, an examination of mass procedures in investment arbitration, and a call for reasoned decisions regarding arbitrator challenges.  
Moreover, volume III delivers valuable information on topical issues such as the applicable law and the interrelation of European Union law, the delimitations of confidentiality, the handling of set off and counterclaims, trends regarding interim relief and the enforcement of arbitral awards in selected jurisdictions.

**Volume IV** – in honour of Pierre A. KARRER – emphasizes indispensable standards in arbitration: contributions cover the role of consent, the demand for control, rules of emergency relief and the prevention of unconscious psychological influences in the decision-making. Further articles focus on the practical issues of documentary evidence and document production as well as on the question of e-discovery.  
This Volume also highlights topics in investment arbitration, such as the UNCITRAL Rules on Transparency, the possible effects of awards on parallel or subsequent proceedings, and the ICSID annulment system as compared to set-aside proceedings before state courts.

**Volume V** – in honour of Martin HUNTER – besides up-to-date issues of general interest, such as case management, confidentiality and impartiality, procedural justice, class action, and recognition and enforcement, includes profound analyses of specific topics in construction, banking and finance, investment, and sports arbitration. Moreover, valuable insights into transnational aspects of mediation and selected national mediation acts and practices are provided, complemented by a first assessment of online dispute resolution within the European Union.

**Volume VI** – in honour of Claudia KAELIN-NAUER – besides discussions of general developments, such as the effects of EU law and Brexit on international arbitration, provides comments on various specific issues of both arbitration and mediation, including construction and investment matters as well as the ever-growing topic of online dispute resolution.
