Terms and Conditions

Agreement with the Paris Lodron University of Salzburg (PLUS)

These Terms and Conditions set the basis of your relationship with PLUS when you apply for our Summer School Program.

Your contract with PLUS is made up of these Terms and Conditions, your application, and the full payment of the tuition fees.

Tuition fees

The fee for attendance of the Summer School amounts to 4.888,- EUR for the long version (with 10% discount for PLUS partner Universities amounting to 4.444,- EUR) and to 3.200,- EUR for the short version (with 10% discount for PLUS partner Universities amounting to 2.880,- EUR). This includes fees for accommodation (including breakfast), bus transfers in Europe, lecture fees, excursion and entrance fees and insurance fees (note: This is only a travel medical insurance! There is no liability insurance included or other kinds of insurance. In case you would like to take out other kinds of insurance, it is expressly pointed out that you must take care of this on your own.).

Please refer to your bank regarding bank transfer fees and make sure that the payment will be received by PLUS without deductions.

Cancellation Period

If you have to cancel your participation in the Summer School, please send us an e-mail with a brief explanation of the reason.

Cancellations after the 15th of April 2025 and before May the 1st will lead to return of 75% of the tuition fee minus transfer fees. Cancellations between the 1st and 31st of May will lead to return of 50% of the tuition fee minus transfer fees. Cancellations after 31st of May will lead to no return of the tuition fee.

Delivery of the Program

Under exceptional circumstances, we may consider it appropriate to cancel or significantly change the course of the Program. This could be for reasons including but not limited to the following:

- If there are not enough applicants registered for the Summer School.
- If an event outside of our reasonable control prevents us from running the Summer School or the Course. Force majeure.

In such cases, the tuition fee will be returned.

In case that the service or event is only partially carried out, the fee will only be refunded on a pro rata basis.

Your Responsibilities

By accepting the conditions, you agree to:

- Be punctual in attending lectures, excursions, and visits and for the transfers. We will record student attendance on a daily basis in class registers.
- You are required to attend ALL CLASSES in order to qualify for an attendance certificate and 5 ECTS credits for the long version and 3 ECTS credits for the short version (apart from sick leave). The following events are also mandatory: Introduction, Final Discussion, Exams.
- If you are absent for health reasons you must inform us by e-mail, WeChat/WhatsApp or in person and such non - attendance will be excused - provided the reason given is credible.

Intellectual Property

All materials provided by the Summer School of the PLUS and any intellectual property rights in them shall remain the property of the PLUS or the professors holding the lectures. You are not allowed to film any of the lectures without the permission of the respective lecturer.

It is agreed that domestic Austrian law shall apply to all disputes arising from the contractual relationship in question, as well as to any tort claims. The courts of the city of Salzburg are agreed as the exclusive place of jurisdiction for all disputes arising from the present contractual relationship, as well as for any tort claims. The subject-matter jurisdiction shall be governed by the rules of domestic Austrian jurisdiction.

PLUS or FOR APAC will not be held responsible for failure to execute obligations specified herein directly or indirectly occasioned by or through or in consequence of war, change of statutes of the Austrian Government, strikes, riots and acts of God or conditions beyond the control of PLUS or FOR APAC.

Rules of Conduct

You are expected to behave as responsibly as at your home institution. In case of violation of the ethical standards as set by your home institution in the framework of this program PLUS or FOR APAC reserve all rights of adequate sanction.
